## **Rate Account and Services Establishment Fee Exemption Application**

Council charges a Rate Account and Services Establishment Fee to establish a new rate account when a property transfers ownership. The fee is exempted in some cases, including where a property changes hands due to death or marriage.

To be eligible, your application must be submitted within 12 months of the title transfer date **OR** within 24 months of the title transfer for new builds on vacant land **AND** the property must be a residential property in Brisbane and must meet **ONE** of the exemption reasons.

Application made for one of the following are **not eligible**:

- purchases of vacant land unless the owner/s builds and occupies a home on the land within 24 months after the title transfer date (applications must be made once the home is occupied)
- purchases made in the name of a trust
- purchases made in the name of a company

To complete this form you will need:

- the property address the application will apply to
- rate account number (located on third page of your rate account)
- details of your name as it appears on the account
