ADOPTION OF MINOR AMENDMENT PACKAGE R, MINOR AND ADMINISTRATIVE AMENDMENT PACKAGE S AND A PLANNING SCHEME POLICY AMENDMENT – AMENDMENT PACKAGE Q

At its meeting on 6 August 2024, Brisbane City Council adopted a planning scheme policy amendment, a minor amendment and a minor and administrative amendment to Brisbane City Plan 2014 including changes to planning scheme policies (Amendment package Q, Minor amendment package R and Minor and administrative amendment package S). All amendments apply citywide and will commence on 13 September 2024

The purpose and general effect of Amendment package Q is to:

introduce a new Subtropical building design planning scheme policy to provide further information and guidance to support the subtropical design outcomes for buildings and outdoor spaces in Brisbane City Plan 2014.

The purpose and general effect of Minor amendment package R is to:

amend the zoning, Dwelling house character overlay and Traditional building character overlay of properties purchased under the Voluntary Home Buy-Back program and other previous buy-back programs, to reflect the requirement the properties be non-habitable.

The purpose and general effect of Minor and administrative amendment package S is to:

- maintain the currency and effectiveness of the Infrastructure design planning scheme policy by reflecting the most up-to-date and accurate information in Brisbane Standard Drawings and other minor text refinements;
- maintain the currency of the planning scheme through changes to the Pre-1911 building overlay mapping to reflect current development approvals and other changes of a minor nature;
- introduce references to the new Subtropical building design planning scheme policy in relevant development codes to provide further information and guidance.
