Adoption of a planning scheme policy amendment - Amendment package N

At its meeting on 23 November 2021, Brisbane City Council adopted an amendment to the Infrastructure design planning scheme policy that supports *Brisbane City Plan 2014* to include changes to public lighting, stormwater treatment devices, Brisbane Standard Drawings and Reference specification requirements (Amendment package N). The amendment applies citywide and will commence on **10 December 2021**.

The amendment updates the infrastructure design standards of the Infrastructure design planning scheme policy to reflect Australian Standards and industry best practice. The amendment:

- reflects the latest Australian Standards AS/NZS1158.3.1 - Lighting for roads and public spaces
- provides a common format for public lighting infrastructure requirements to improve readability and understanding of public lighting standards
- updates the Infrastructure design planning scheme policy to reflect industry best practice and standards for the delivery of lighting and other Council infrastructure by amending, adding and removing Brisbane Standard Drawings and Reference specifications
- ensures proprietary stormwater treatment devices have appropriate certification and demonstrate the required performance metrics of *Brisbane City Plan 2014*.

Public notice of decision to adopt interim amendment to Brisbane City Plan 2014: Local government infrastructure plan (LGIP) (Interim LGIP amendment 1a) and tailored amendment to Brisbane City Plan 2014: Long term infrastructure plans (LTIP) (LTIP amendment 1a)

At its meeting on 23 November 2021, Brisbane City Council (Council) decided to adopt an interim LGIP amendment to the *Brisbane City Plan 2014* (Planning Scheme) to amend the Local government infrastructure plan (LGIP) (Interim LGIP amendment 1a) and a tailored amendment to the Planning Scheme to amend the Long term infrastructure plans (LTIP) (LTIP amendment 1a). The Interim LGIP amendment 1a and the LTIP amendment 1a apply city-wide and commence on 10 December 2021.

Purpose and General Effect

The Interim LGIP amendment 1a and the LTIP amendment 1a are intended to:

- Better align the LGIP and LTIP with Council's priorities and commitments;
- Provide clarity for decision making for Council, landowners and developers in relation to the intended delivery of trunk infrastructure; and
- Help preserve Council's ability to deliver long term infrastructure when it is required

 - (f) make appropriate changes throughout to the positions of Chair and Civic Cabinet Chair.
4. The local law commences on 10 December 2021.


