**Notice of adoption of a major amendment to Brisbane City Plan 2014 pursuant to Section 20 of the Planning Act 2016 and Section 22.1(b) of Part 4 of Chapter 2 and Schedule 5 of the Minister's Guidelines and Rules made under Section 17 of the Planning Act 2016.**

At its meeting on Tuesday 11 February 2020, Brisbane City Council adopted amendments to Brisbane City Plan 2014 to stop townhouses and apartments from being built in areas for single-homes (Major amendment package H). The amendments apply city-wide and will commence on 1 May 2020.

**Purpose and General Effect**  
The amendments are intended to:

- remove provisions in zone codes, development codes and neighbourhood plans supporting Multiple dwellings (townhouses and apartments) in the Low density residential zone, and
- amend other relevant provisions in City Plan to align with this change, including amendments to the Strategic framework, and make necessary consequential amendments.
