SUBORDINATE LOCAL LAW) NOTICE (NO.1) 2023**

Title

1. This notice may be cited as the *Sunshine Coast Regional Council (Making of Amendment Local Law and Amendment Subordinate Local Law) Notice (No. 1) 2023*.

Commencement

2. This notice commences on the date it is published in the Gazette.

Making of amendment local law and amendment subordinate local law

3. The Sunshine Coast Regional Council made, by resolution on 25 May 2023, *Amendment Local Law No.1 (Miscellaneous) 2023* and *Amendment Subordinate Local Law No. 1 (Miscellaneous) 2023*.

Local laws amended

4. *Amendment Local Law No. 1 (Miscellaneous) 2023* amends the following local laws:
 - *Local Law No. 1 (Administration) 2011*;
 - *Local Law No. 2 (Animal Management) 2011*;

MINOR AND ADMINISTRATIVE AMENDMENT PACKAGE N

At its meeting on 16 May 2023, Brisbane City Council adopted a minor and administrative amendment to *Brisbane City Plan 2014* and the Infrastructure design planning scheme policy (Minor and administrative amendment package N). The amendment applies citywide and will commence on **2 June 2023**.

The purpose and general effect of Minor and administrative amendment package N is to:

- maintain the currency of the planning scheme through changes to reflect updates to the *Planning Regulation 2017* made through the *Planning (Rooming Accommodation) Amendment Regulation 2022*;
- maintain the currency of the Infrastructure design planning scheme policy to reflect the most up-to-date and accurate information in Brisbane Standard Drawings;
- make minor updates to design parameters for rooftop gardens to reflect current industry practice and construction standards; and
- improve the effectiveness and useability of the planning scheme by enhancing the format and presentation, undertaking text refinements and making typographical changes.
