LOCAL LAW NO. 2 REGULATED PARKING PERMIT 1996

LOCAL LAW NO. 3 ROBERTSON MACGREGOR REGULATED PARKING 1996

- **6.(1)** Where pursuant to any Act or instrument thereunder any matter or thing may be determined by resolution of the Council, unless the contrary intention appears, expressions used in any such resolution shall have the same meanings they would have if that resolution were a section of that Act or a provision of that instrument.
 - (2) In this ordinance the term "instrument" means any regulation, rule, by-law or ordinance.
 - 7.(4) For the purposes of paragraph (1) -
 - (b) "the proper officer" means -
 - (i) in any case, the Chief Executive Officer;
 - (ii) in any case where the resolution of the Council is in relation to some matter arising out of the business of the Council conducted by a particular unit of administration, the permanent head of that unit of administration;
 - (iii) in any case where the resolution of the Council is in relation to some matter within a class of matters specified in a determination made under paragraph (2), the officer of the Council who by that determination is a proper officer for the carrying into effect of that resolution.
 - 8. Without prejudice to the express provisions of any other ordinance, where-
- (a) provision is made in an ordinance for a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval to be made, given, granted or issued by a particular Council authority; and
- **(b)** that ordinance is thereafter amended in such manner that thereby such a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval is to be made, given, granted or issued by another Council authority or by the Council, any such a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval in force immediately before the commencement of that amendment shall on and from such commencement have effect as if it were made, given, granted or issued by that other Council authority or by the Council, as the case may be.
 - 9. Without prejudice to the express provisions of any other ordinance, where-
- (a) provision is made in an ordinance for a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval to be made, given, granted or issued by the Council;
- **(b)** that ordinance is thereafter amended in such manner that thereby such a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval is to be made, given, granted or issued by a particular Council authority, any such a determination, direction, requisition, certificate, notice, license, permit, registration, authority or approval in force immediately before the commencement of that amendment shall on and from such commencement have effect as if it were made, given, granted or issued by that particular Council authority.

12. Where -

- (a) provision is made in an ordinance for a particular power, function or duty to be exercised, discharged or performed by a particular Council authority; and
- **(b)** that ordinance is thereafter amended in such manner that thereby such power, function or duty ceases to be vested in or imposed upon that Council authority and is vested in or imposed upon the Council, that power, function or duty may be exercised, discharged or performed by that Council authority at any time after the commencement of that amendment and prior to -
 - (i) the expiration of 28 days after that commencement;
 - (ii) a determination by the Council by resolution after that commencement that the provisions of this ordinance shall, with respect to that power, function or duty, cease to have effect; or
 - (iii) the delegation by the Council after that commencement under section 39B of the City of Brisbane Act 1924-1987 of that power, function or duty,

whichever shall first occur, as if that Council authority were the Council and for the purposes of giving effect to this ordinance the Council shall be taken to have, by resolution made at that commencement under section 39B, duly delegated that power, function or duty to that Council authority for its exercise, discharge or performance at any time prior to whichever of those events specified in subparagraphs (i), (ii) and (iii) shall first occur.

- 13. For the purposes of ordinances 8, 9, 10, 11 and 12, any of -
- (a) the Mayor;
- (b) any committee appointed from among the aldermen;
- (c) any board consisting of officers of the Council; and
- (d) any officer of the Council,

shall be a Council authority.
