# Regulated Parking Permit Application Car-Share Permit

## **Permit information**

Car-Share Permits may be issued to a Car-Share Operator in relation to a car-share vehicle that is owned by the corporation or business for the purpose of short-term hire to its members, which may need to operate within one or more Regulated Parking Permit Scheme Areas.

Vehicles must be currently registered in Queensland, and the Car-Share Operator's company logo and contact details must be clearly visible. Car-Share Operators may apply for any number of Car-Share Permits up to the maximum number of eligible registered vehicles operated by that business.

Car-Share Permits are not transferrable from one Car-Share business to another, and will not be issued for operators conducting a Peer-to-Peer Car-Share Operating Model.

A Car-Share Permit may be transferred from one vehicle to another, provided it meets the required criteria:

- the details of the vehicle to which the permit is to be transferred are provided to Council; and
- the vehicle to which the permit is to be transferred is a replacement for a vehicle that is being removed from the car-share business; and
- the relevant Car-Share Operator owns or leases both vehicles.

Car-Share vehicles will be restricted from parking in respective traffic areas on event days and in 15 minute parking limit signed areas. Permits will not be issued for parking in the Roma Street Parkland precinct, South Bank and on-street in the suburb of Brisbane City.

Car-Share Permits are valid for the date/s specified on the permit.

#### Fee

**\$400.00** (GST excluded) application fee per vehicle.

#### Please note:

- The application form will not be processed unless all required details are completed, and supporting documents provided.
- Permits cannot guarantee car-share members access to on-street parking.

**WARNING** - misuse of permit may result in cancellation.
